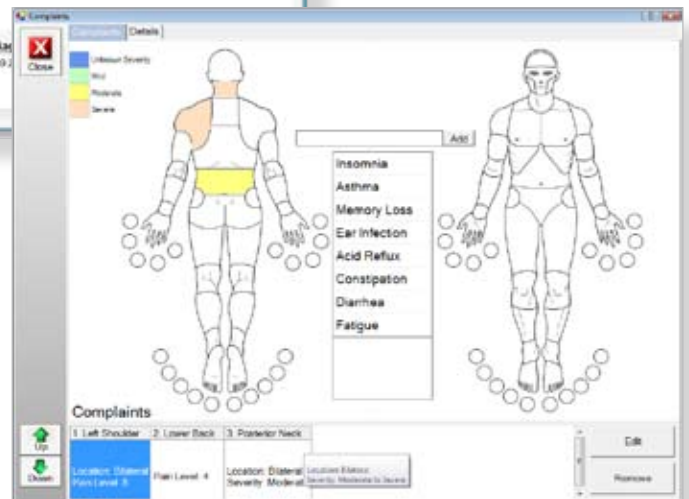
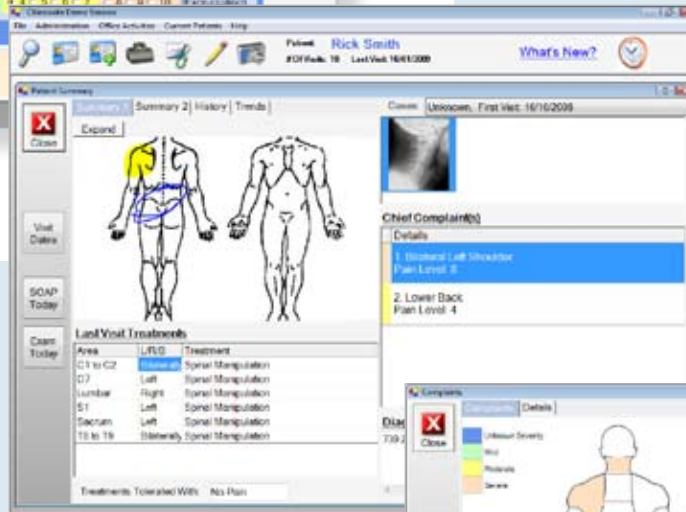
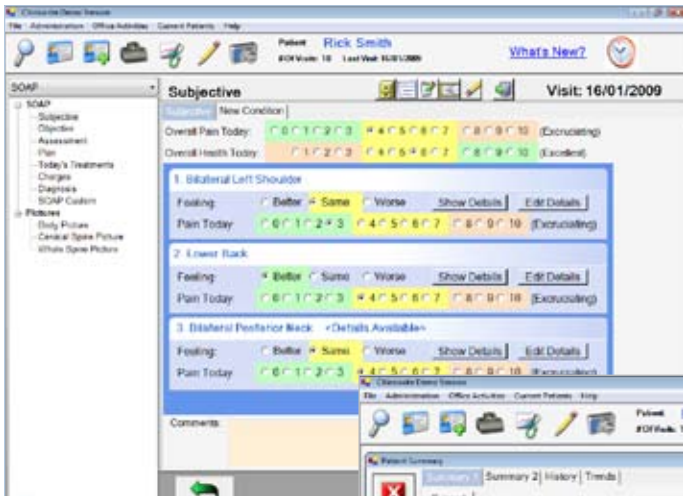

OCA ChiroWrite is a licensed clinical notes software product available to Canadian chiropractors and their associates. This state-of-the-art software offers an easy way to record patient visits and examinations so that SOAP notes and narratives can be effortlessly produced.

Most medical questionnaires and forms that chiropractors use are included and custom forms can be added.

ChiroWrite has the ability to produce a comprehensive list of reports based on the information input into the system.

PROGRAM FEATURES

- **Interfaces with OCA's Patient Management Program**

A PMP integration feature has been created that will import PMP patient information into ChiroWrite. PMP will automatically transfer patient files during scheduled appointment times and a group export feature is also available. ChiroWrite reduces duplication when creating patient files and updating patient information because information changed in PMP is automatically updated in CW.

- **Easy to use interface**

Utilizing an efficient screen layout, flow and navigation boxes ensure that the time-consuming task of writing notes is greatly reduced.

- **Compliance with standard record keeping guidelines**

ChiroWrite helps you conform to standard professional record keeping guidelines

- **Option to copy prior visit information**

ChiroWrite allows practitioners to copy the information from a prior visit to the current visit. For example, when recording a SOAP note and the information from this visit is the same as the last, copy the last visit and you are done. When you are doing a final exam, copy the initial or progress exam results and then change values as necessary.

- **Customize exam and SOAP screens using the Workflow engine**

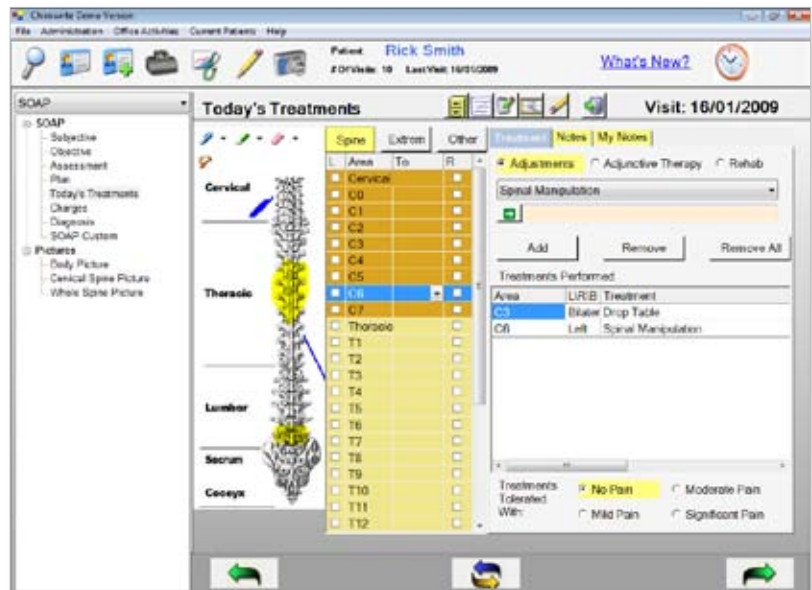
ChiroWrite provides a unique workflow engine called Worxflow. This allows practitioners to configure the order in which the examination and SOAP screens appear. You can configure multiple workflows so that you see only the tests you want to use. This feature reduces the number of items to go through when completing examination or SOAP notes.

- **Configure sentence structure using the WorxPhrase engine**

The WorxPhrase engine allows you to configure standard sentences and paragraphs that you use often and store them for quick retrieval.

- **Customizable buttons that input pre-defined information**

Create template-like buttons to populate patient SOAP notes using the patient's current information.



- **Use your own graphics**

The system has been designed to allow you to configure your own images into our workflow. This allows you to continue using images you are familiar with, such as drawings of the spine, body, muscle groups, etc.

- **Include patient images**

Images such as x-rays and other photos can be attached to the patient's file and they are visible on the patient's summary screen. You are able to mark x-rays and make personal notations.

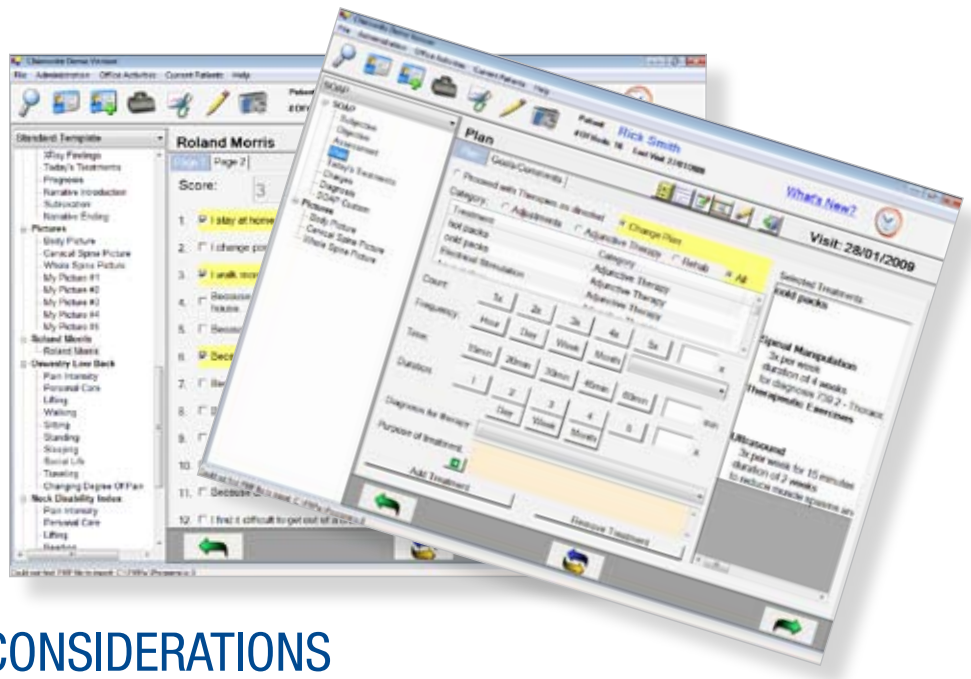

CHIROWRITE TECHNICAL CONSIDERATIONS

INITIAL LICENCE FEES

The ChiroWrite software package is available to PMP users at a preferred licensing rate. The primary chiropractor's initial licence fee is \$799. The licence fee for additional chiropractors in the same practice is \$449 each. The licence fee for non-chiropractors in the same practice is \$199 each. The initial licence fee for a primary chiropractor who does not use PMP is \$899. When additional non-PMP practitioners in the same practice are being added to ChiroWrite, the licence fee for chiropractors is \$549 each and the licence fee for non-chiropractors is \$199 each. All practitioners, chiropractors and non-DCs, who practice in more than one location will be charged a \$25 administration fee for the second location and each subsequent location. Applicable taxes will be added to all the above fees. The initial package includes software, a User Manual and unlimited, telephone support for the period up to July 31.

LICENSING AND SUPPORT

The Ontario Chiropractic Association retains the right to licence all ChiroWrite programs. Practitioners who maintain their annual licence agreement will have the right to use ChiroWrite on a yearly basis. Annual licence fees are not pro-rated and discounts and refunds do not apply. The annual licence fee includes unlimited, toll-free telephone support for the period up to July 31. A contractual relationship exists between the OCA and the primary licensee which defines the rights and responsibilities of each party. Only the primary licensee has permission to authorize changes to ChiroWrite including but not limited to adding, updating and deleting practitioners. Changes can only be made to the ChiroWrite program with the permission of the OCA and the knowledge and express written permission of the primary licensee.

ANNUAL LICENCE FEES

All practitioners choosing to use ChiroWrite must pay an annual licence fee in order to maintain the right to use the program. Preferred licensing rates apply to offices using PMP. The annual licence fee is \$799 for the primary chiropractor, \$449 for each additional chiropractor in the same practice and \$199 for each non-DC in the same practice. The annual licence fee for a primary chiropractor who does not use PMP is \$899. The licence fee for additional chiropractors in the same practice who are non-PMP users is \$549 each. The licence fee for non-chiropractors in the same practice who are non-PMP users is \$199 each. All practitioners, chiropractors and non-DCs, who practice in more than one location will be charged a \$25 administration fee for the second location and each subsequent location. Applicable taxes will be added to all the above fees. The annual licence fee covers the cost of program enhancements, updates and unlimited, toll-free telephone support for the period from August 1 to July 31. The primary licensee must renew the licence by August 1st of each year in order to receive the program update. This applies to all practitioners within the same clinic. Until full payment is received for all practitioners a ChiroWrite update will not be released to the clinic.

- Intel Pentium 4 1.6 GHz or equivalent with 5 GB free space on hard drive
- On-site internet connection

ChiroWrite was designed for touchscreen monitors and Tablet PCs. It also works on a regular computer system with a mouse. If you plan to have ChiroWrite on more than one computer, your computers must be networked.
